SUBJECT: ORAL REPORT OF THE PROGRAM MANAGEMENT CHIEF OFFICER

RECOMMENDATION

RECEIVE oral report by the Program Management Chief Officer.

DISCUSSION

- A. Update report covering the month of July 2017 by the Program Management Chief Officer; and
- B. At the January 2017 meeting, the Board authorized a one-year pilot program authorizing the CEO to negotiate and execute project-related agreements, including contract modification(s) up to the authorized Life of Project budget, to streamline project management of the four (4) major transit corridor projects (Crenshaw/LAX, Regional Connector, Westside Purple Line Extension Section 1 and 2 projects). In addition, staff was directed to provide monthly reports, that would include any pending project-related agreements, change orders/contract modifications and any significant changes to contingency.

Pursuant to the Board motion, staff has developed and begun reporting on cost contingency and contract change activity starting in the February 2017 Monthly Update to the Construction Committee. This new report includes a project cost contingency drawdown curve and allows the Board to see project-related and change activity. This report can be found in Attachment A.

- At the conclusion of the one-year pilot program in January 2018, staff will report back to the Board on the time saved as result of this pilot program, and any lessons learned, and recommendations for the Board review and further direction.
- C. Program Management is continuously improving project delivery through innovation and application of best practices. Attachment A summarized the progress achieved in FY2017.





- Overall Project Progress is 20% complete.
- Excavation for the Wilshire/La Brea Station commenced on October 12, 2016 and continues beneath the deck panels. First level walers and struts are complete and second level excavation, waler and strut installation is on going. Station excavation is scheduled to complete by December 2017.
- The Wilshire/Fairfax pile installation operation completed on February 8, 2017. Street decking commenced on the weekend of February 11, 2017, and completed on June 19, 2017. Steady-state traffic control is anticipated in mid-July 2017.
- The Wilshire/La Cienega Station piling operation, which commenced on March 20, 2017, continues. Stage 1 piling along the south side of Wilshire Boulevard is complete. The traffic switch to the north side of Wilshire Boulevard for Stage 2 piling occurred on June 24, 2017.
- The jet grouting operation along Wilshire Boulevard at the cross passages continues. This work along the tunnel section from Wilshire/La Brea to Wilshire/Western is scheduled to continue through October 2017.
- Tunnel Boring Machines (TBMs) are being fabricated for delivery at the end of 2017. Tunneling is planned to start in 2018.

- Construction of the telecom joint trench is proceeding in Century City. Duct bank work planned completion is June 2017 and subsequent cable pulling/splicing is anticipated for completion in September 2017.
- Los Angeles Department of Water and Power utility relocations began at the Century City Constellation Station in May 2017 for both water and power.
- Negotiations with the City of Beverly Hills for a Memorandum of Agreement governing utility work began in March 2017 and is continuing.
- Beverly Hills City Council approval for the construction permit is anticipated in June 2017.
- Advanced utility relocations are anticipated to begin at the Wilshire/Rodeo Station in July 2017.






