**6. SUBJECT: ORAL REPORT ON TRANSIT AND HIGHWAY PROJECTS 2023-0293**

RECEIVED oral report on Transit and Highway Projects.

Director Campbell requested that for future presentations, all the units of measure were the same.

Director Rajmaira and staff discussed the slide in schedule for Westside and staff explained that the reason is because of tunnels and resources. They are working with the contractor on resequencing the work schedule.

The Director also asked for additional commentary on the I-105 project. Staff said that pre-contract work is currently underway and a Life of Project (LOP) has yet to be established.

Director Stanger questioned whether the cross-tunnel work is being performed by the tunnel contractor or a separate contractor. Staff responded that it is the tunnel contractor performing the work and that they were aware of the magnitude of the work.

He also asked for clarification regarding the planned connection of the West Santa Ana Branch and the Blue Line. Staff said the Metro Board had approved the Line to continue into Downtown Los Angeles, but the first phase would end at Slauson. Director Stanger's concern lies with the capacity of the Blue Line once the first phase of the West Santa Ana Branch is complete. Additionally, there is nothing in the Measure M Ordinance that might fund improvements at the Washington/Flower junction. Staff responded that they are looking at improvements to the Y junction in the area.

He added that the bike lane along the coast is heavily used, can be quite dangerous, and is in need of expansion, yet is not in the plan thru 2057. He questioned how the program might address such a priority.
