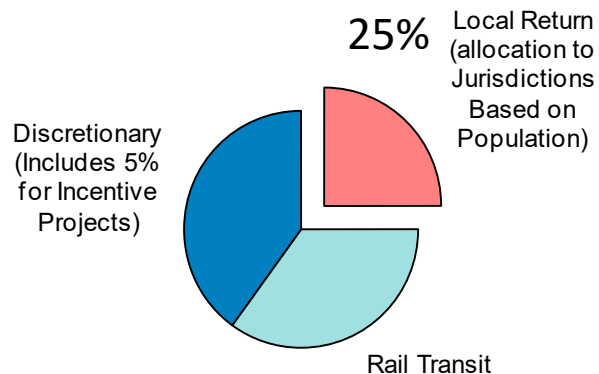

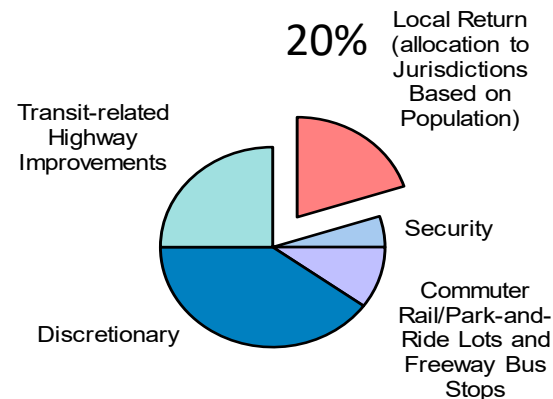

Prop C (approved in 1990)

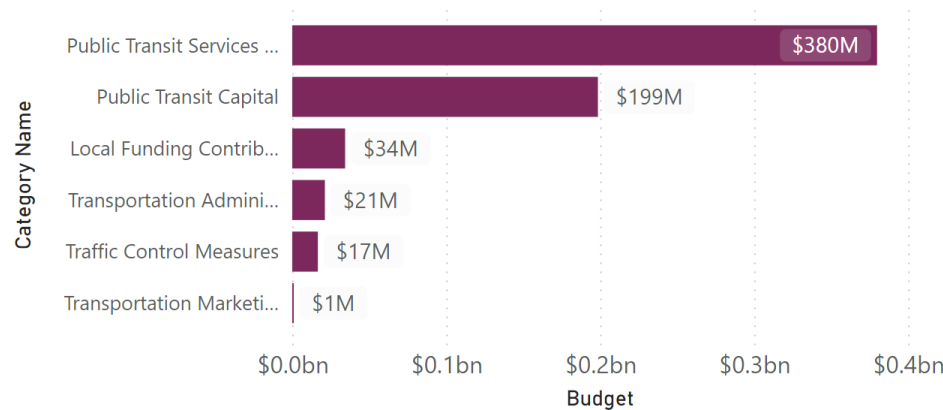

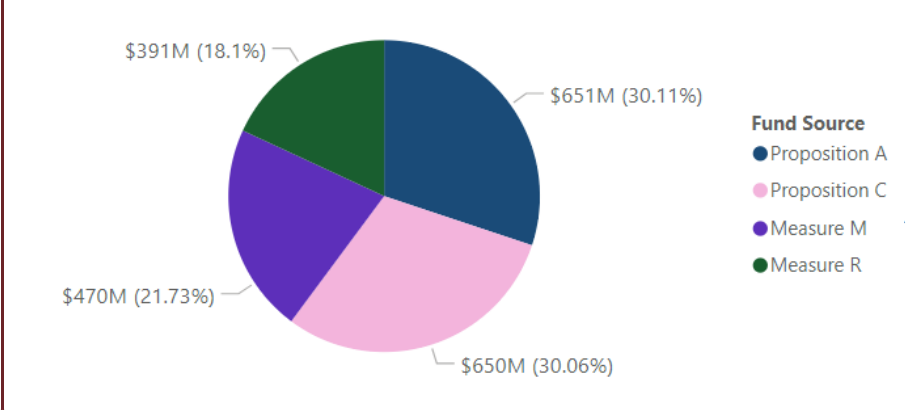

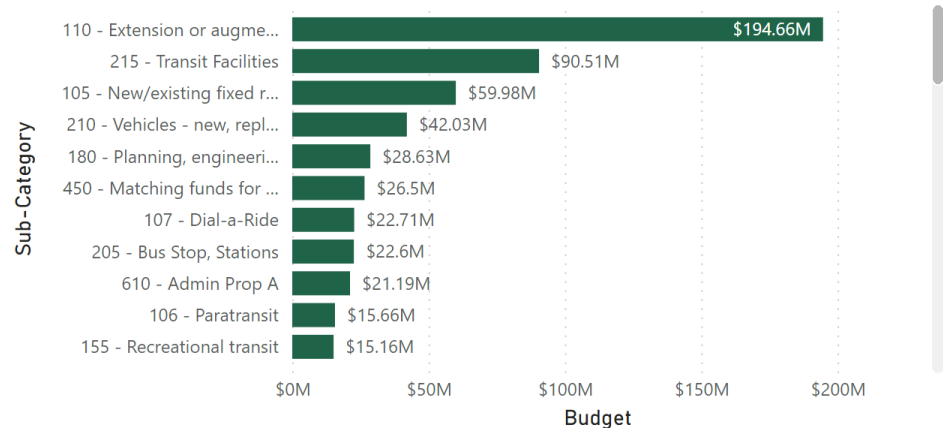
Budget by Category Name



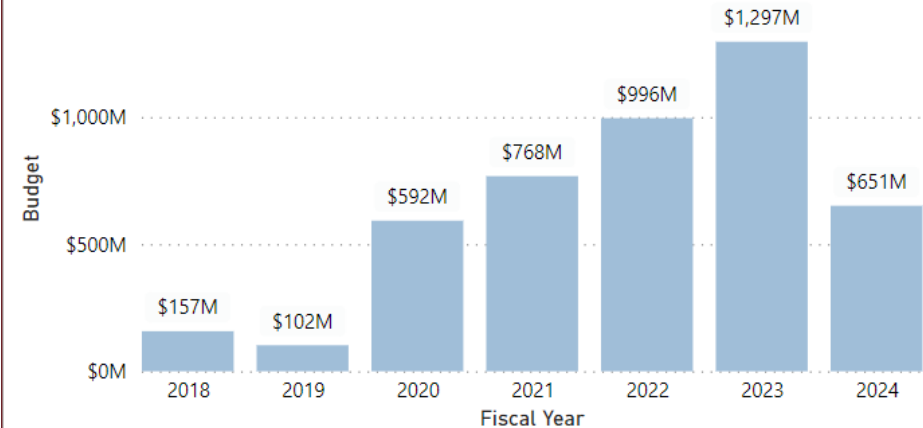
Budget by Fund Source

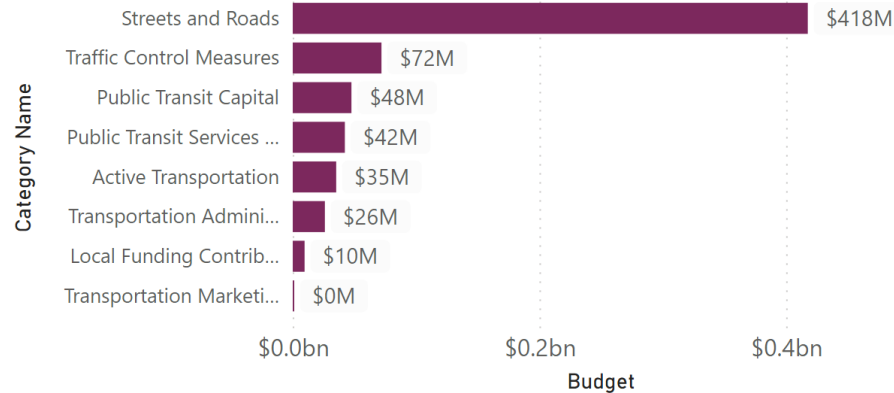

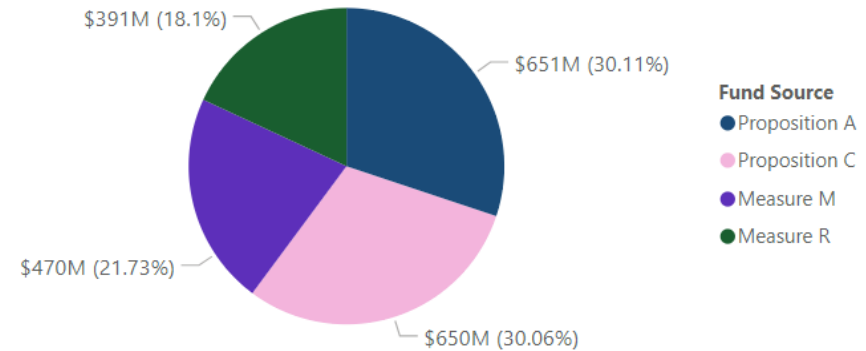

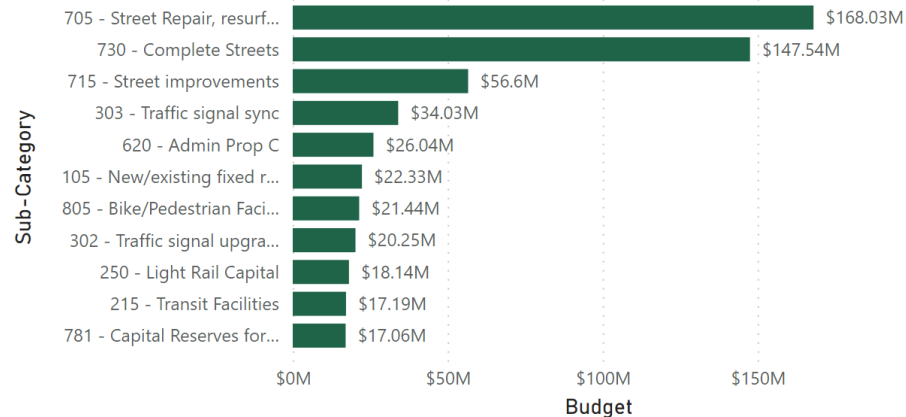

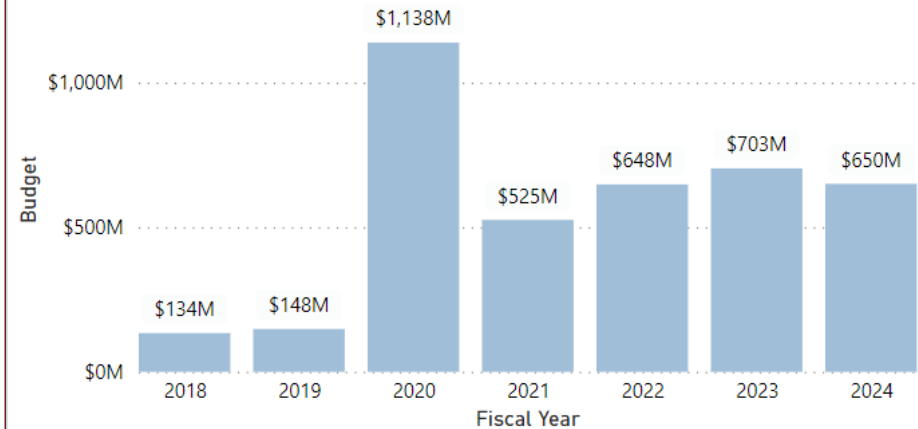
